**PURCHASE TERMS**

**Purchase Orders under \$1,000.00:**

100% prepayment by check or credit card.

Purchase Order's that remains due 15 days after date of delivery will be charged an interest rate of 1.5% per month.

**Purchase Orders over \$1,000.00:**

50% deposit at time of Purchase Order and 50% due upon delivery.

2% discount for 100% payment at date of Purchase Order.

All Purchase orders paid by credit card will be charged 3%.

Order does not commence until time of deposit; delivery within six to eight weeks.

Cancellation within 10 days will receive full refund. After 10 days a restocking charge will be applied.

**SHIPPING**

All orders are plus freight (except Standard Packaging Products). Orders shipped out of the continental US will require a special freight quote.

**WARRANTY**

LEDCO warrants each LED fixture and accessory to comply with its respective published specifications, to be free from defects in material, workmanship, title, and to operate from the date of manufacture for the periods listed below and subject to the Terms Conditions.

If an LED fixture or accessory fails to operate for the warranty period, LEDCO will provide free replacement of the failed product in accordance with the Terms and Conditions set forth below.

This limited warranty only applies when LEDCO components are properly wired and installed together as a system; are operated within the electrical values shown on LEDCO lighting fixture label and used in situations approved for the application and in the environmental conditions (temperature and humidity) within the normal specified operating range of the system. This warranty does not apply to any acts of God or because of any abuse, misuse, abnormal use or use in violation of any applicable standard, code or instructions for use in installations. This warranty will not apply in the event of conditions demonstrating abnormal use or stress, including under/over voltage conditions, operating hours, and operation at an ambient temperature higher than 40 degrees C lasting greater than 10 hours. Replacement of the LEDCO component with LED light components of other manufacturers will void entire warranty.

**RETURN OF PRODUCT**

LEDCO must issue RMA # for all returns. To make a warranty claim, notify LEDCO within thirty (30) days of the failure. If you are unsure, whether a situation exists that is covered by this warranty, please contact LEDCO for assistance. A 50% restocking fee may apply to any non-warranty return.

**LIMITS OF LIABILITY**

The foregoing shall constitute the exclusive remedy of the purchaser and the sole liability of LEDCO warranties. IN PARTICULAR, NO WARRANTY OR MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS MADE OR IS TO BE IMPLIED. In no event shall LEDCO be liable for any other costs or damages, including lost profits or revenues, incidental, special or consequential damages.
